What is DUI MAT?

The DUI MAT Outreach Program is a recognition and intervention program for the identification and treatment of opioid and polysubstance use disorder to benefit DUI program participants.

Because your DUI Program is a DUI MAT provider. You will receive Substance Use Disorder education and voluntary prescreens. You can also elect to join the DUI MAT Program, if you decide it is right for you. DUI MAT is a voluntary program and will not impact your DUI program or any legal proceedings.

Talk to your counselor to find out if DUI MAT is right for you!

What is MAT?

Medication-assisted treatment (MAT) is FDA approved medication for the treatment of opioid and alcohol use disorders (OUD/AUD). Combined with counseling, MAT is very effective and has become the standard of care for OUD. MAT helps to stabilize the brain, control cravings, and helps people recover. Without MAT, there is a high risk of relapse and overdose. MAT supports long-term recovery.

Benefits of MAT

- Reduces or eliminates drug withdrawal.
- Reduces or eliminates cravings.
- Blocks the effects of opioids and alcohol.
- Stablilzes brain chemistry.
- Recognized as standard of care for OUD.

Is DUI MAT Right for You?



DUI MAT is available to any person enrolled in a DUI Program offering DUI MAT services. If you think you may have a substance abuse issue, this program may be right for you. The first step to determining eligibility is to complete the 10-question prescreen provided to you by your DUI Program. Depending upon the results, a 2nd level assessment may be available at no charge to you.

Upon completion of the 2nd level assessment you will meet with your counselor, certified in working with Substance Use Disorder. As a DUI MAT program participant, you will meet with a DUI MAT counselor on a regular basis as you attend your treatment program referrals. DUI MAT will be available at select service locations through June 2024. Talk to your counselor to find out if DUI MAT is right for you!

Poly Substance Use Disorder (PolySUD)

PolySUD is the use of two or more substances, including any two drugs or one drug and alcohol, that creates a dependency and a negative impact in life.

PolySUD substances include alcohol, marijuana, meth and other stimulants, prescription pills, and more.

Some PolySUDs may not be treated with MAT (such as marijuana and meth), however, there are other treatment options available.

DUI MAT is a program for those who may need help with an OUD or PolySUD.

Benefits of the DUI MAT Program

DUI MAT is a voluntary program.

The DUI MAT program is completely separate from your DUI Program Requirements and is confidential.

Your participation in the DUI MAT Program will not affect your DUI court case, probation requirements, or your status with the DMV.

As a participant, you will receive a free advanced assessment which will help determine the treatment resources that may benefit you.

You will receive treatment referrals to community providers that address your unique needs.

You will receive additional counseling services from your DUI counselor at no charge to you.
